We would like to inform you about the COMPETITION PROGRAM and the applicable DEADLINES for the **2023 IWF World Championships (Paris 2024 Qual. Event)** to be held in **Riyadh, Kingdom of Saudi Arabia**.

COMPETITION PROGRAM

- **04 JUNE 2023** / PRELIMINARY ENTRY DEADLINE
 - **3 months before the IWF WC**
- **04 JULY 2023** / FINAL ENTRY DEADLINE
 - **2 months before the IWF WC**
- **21 AUGUST 2023** / VERIFICATION OF FINAL ENTRIES (Online)
 - **2 weeks before the IWF WC**
- **03 SEPTEMBER 2023** / TECHNICAL MEETING
- **04-17 SEPTEMBER 2023** / IWF WORLD CHAMPIONSHIPS
 - **12 SEPTEMBER 2023** / IWF CONGRESS

DEADLINE for the PRELIMINARY ENTRIES is 04 JUNE 2023.

IMPORTANT

- The **2023 IWF World Championships** is a **COMPULSORY EVENT** to qualify for the **OLYMPIC GAMES PARIS 2024**.

- **By the Final Entry deadline of 04 JULY 2023, participating Member Federations MUST pay the ENTRY FEE to the Organizing Committee. Those who do not pay by the above date may be declared ineligible for the competition.**

IN ACCORDANCE WITH THE IWF TCRR, IT IS MANDATORY ALL ATHLETES TO REGISTER BEFORE THE PRELIMINARY ENTRY DEADLINE FOR THE IWF WC.

For this purpose, you can now register up to **20 ATHLETES / GENDER** even though the final number of competitors can only be a maximum of 10 athletes (+2 Reserves) per gender, which you shall select by the Final Entry deadline.

ENTRIES CAN ONLY BE REGISTERED VIA THE IWF ONLINE ENTRY SYSTEM AT

Please make sure that all your athletes are included in the preliminary registration, because, AFTER 04 JUNE 2023, NO MORE ATHLETES CAN BE REGISTERED.

ELIGIBILITY

- In accordance with Article 5.5.16 of the IWF Anti-Doping Rules, the whereabouts information of the athletes shall be submitted **at a minimum of three (3) months** prior to the IWF World Championships (IWF WC).
- Athletes who wish to compete at the IWF WC shall submit their whereabouts information for the period outlined above at the latest on **04 JUNE 2023**.
- ADAMS Deadline for **Q2 2023** in regards to the IWF WC: **04 JUNE 2023**.
- ADAMS Deadline for **Q3 2023** in regards to the IWF WC: **30 JUNE 2023**.

In case of failure to provide the whereabouts information by the Member Federations, the respective Athlete(s) for which the whereabouts have not been submitted **shall be automatically ineligible from competing at the ensuing IWF Event in question.**
